Exhibitors are encouraged to contribute one door prize with a value not to exceed \$50. If you bring one, please leave it at the registration table when you check in that morning. Also, due to space constrictions, please limit the number of individuals at your booth to two people at a time.

### **CANCELLATION POLICY:**

By submitting the registration materials for the practice opportunity fairs, Exhibitors are committing to attending and exhibiting for the duration of the event(s). If for some reason exhibitors are unable to attend after submission of the registration materials, written notice must be received by the GBPW 14 days before the event in which case one-half of the registration fee will be refundable. Within 14 days of the event, there will be no refund for cancellations unless another party is available to fill the vacant spot. If another exhibitor is available to fill the vacant spot, all but \$25 will be refunded.
