**Action**

On **Motion (Waters/Hanly)**, the Board approved the practice location request of Jane Maddox, MD., to add another satellite office in Cochran, Georgia, Bleckley County.

On **Motion (Waters/Hatchett)**, the Board approved the practice location request of Kirk Munsayac, D.O. in Wheeler County Georgia pending further clarification of site details.

On **Motion (Waters/Lowry)**, the Board approved the practice location of Meredith Udell, M.D. in Hartwell, Georgia, Hart County.

**BUDGET REQUESTS AMENDED FY2013 AND FY2014**

Ms. Tucker informed the Board the Governor's budget instructions call for a 3% reduction plan be submitted to the Governor's Office of Planning and Budget for both the FY2013 Amended Budget (current fiscal year) and for the FY2014 Budget. This equates to a reduction of \$1,344,170. Staff presented a proposed reduction plan to the Board which included a 1% reduction in Administration, 0% reduction to the program Physicians for Rural Areas (Scholarships and Loan Repayment), and a 3.1% reduction for all other programs of the Board: Undergraduate Medical Education, Mercer School of Medicine Operating Grant, Morehouse School of Medicine Operating Grant and Graduate Medical Education.

**Action**

On **Motion (Lowry/Waters)**, the Board approved the FY2013 Amended and FY2014 Budget recommendations as presented.

On **Motion (Johnson/Lowry)**, the Board voted to have staff and the Chairman prepare an outline of GBPW budgetary issues and to develop a plan to present to the appropriate parties as soon as possible.

The Board meeting adjourned at 3:40 p.m.
